The proceeds from the sale will be restricted for future development of programs and services that meet the needs of our ever-changing community. I was recently asked if any of the residents from the Seacrest Village at Rancho Bernardo community were moving to Seacrest Village at Encinitas. I assure you that all residents were offered the opportunity and several have already done so.

Seacrest at Home (our home care company) continues to support those living in their own homes in the greater San Diego community who want care brought to them. Demand for this type of service is increasing; one of the greatest challenges is finding enough qualified employees to meet the demand. As we do our best to take care of those who live in our Seacrest communities, we are doing our best to care for those who choose to stay in their own homes.

I also want to note something that is very important to me. Seacrest Village cares for almost thirty Holocaust Survivors. It is a privilege and a great honor to serve their unique needs and to have the opportunity to treat them with the love and respect that they so deserve. Our staff are keenly aware and specially trained to be understanding of any unique needs they may have. This is one of our greatest priorities.

I look forward to writing to you again as my term progresses. I am eager to begin working with the organization in this capacity.

Imagine a family of five living in their home during a complete kitchen, dining, and living room renovation. Now, multiply that by fifty, and you'll begin to appreciate what our 250 Seacrest Village Encinitas residents have been experiencing in their own home!

Since January, when our major undertaking began, meal preparation and delivery to each of our five dining rooms have occurred from temporary kitchens located in our parking lot. As you can imagine, our culinary staff has already racked up hundreds of thousands of steps as they go back and forth from the temporary kitchens to the dining areas spread across several buildings. Given the location of my office, I can see firsthand the tremendous effort each staff person makes as the heavy food carts are skillfully maneuvered along the lengthy sidewalk on their merry way to serve our residents. I marvel at them and wave from time to time, appreciating their willingness to take the extra steps (literally!) and often during heavy rains to serve our residents.

Our Ellen & Ingram Chodorow Synagogue has become the main dining area for many of our residents, which of course has impacted our Rabbi, Life Enrichment, and Building Services staff who have had to relocate and rearrange our programs and services to other locations throughout the campus. A project like this impacts everyone, especially our residents who have been incredibly supportive and patient throughout the process which is expected to continue through October!

I'm sure when the project is complete we will look back and wonder how in the world we did it while relishing our brand-new, state-of-the-art kitchen and newly expanded dining and living room areas. I admire the perseverance of our staff and the resilience of our residents, and I want to thank everyone involved in this major undertaking that is necessary to support and enhance our Seacrest operations.

I also want to recognize and thank Jon Halberg, our out-going Seacrest Village Board Chair, for his tremendous service these past two years. As a relatively recent transplant to southern California, I am still acclimating to the wonderfully consistent and moderate weather that we enjoy year-round. Other than a few rainy days during the winter months, a bit of "gray in May", some "gloom in June", and a few muggy afternoons in the summer, we in San Diego are blessed with a climate that is the envy of so many who live in less weather-friendly states. However, this gorgeous weather can also present a bit of a challenge; as someone who grew up in the mid-west with its four seasons, getting used to paradise isn't easy. Please don't get me wrong; I have no complaints, but occasionally I lose track of what month it is and where we are in the calendar!

I think this is the reason I so love the cycle of the Jewish year. Look up in the sky...if there's no moon, it's Rosh Chodesh, the first of a new Hebrew month. If the moon is full, it's the fifteenth of a Hebrew month. The festivals come just when they should: Sukkot in the fall, Passover in the spring, and Shavuot in the early summer. There is no such thing as a holiday being "early" or "late." It arrives at exactly the right time! Following a lunar calendar makes so much more sense than a solar calendar; it syncs the rhythms of our own bodies with the rhythms of nature.

At no time is this felt more acutely for us as Jews than when we move into autumn and our most important Holy Days. Beginning with the meditative observance on Selichot, (Saturday, September 21) and moving through to the celebration of Simchat Torah, (Tuesday, October 22) we feel the ebb and flow of Jewish time. We reflect, repair, resolve and return. The familiar cycle of these days centers us and brings us back to our better selves, giving us the promise of a clean slate.

Wishing you a New Year filled with health, happiness, gratitude and peace. Shana Tova u'Metukah!

Care, as we all know, comes in many incarnations. From seemingly insignificant tasks like transportation to a doctor's appointment, to providing around-the-clock assistance to someone coming home from a surgical procedure or hospitalization, Seacrest's in-home care service has been serving our clients' needs since 2013. With 2020 on the horizon, not to mention the looming 2030 date when all Baby Boomers will be over 65 years of age, Seacrest at Home has identified additional avenues to deliver our unique level of care to more people. So, (you may ask) where do we go next? What does our expansion of care look like? Home health care.

Home health, as you probably already know, allows licensed R.N. staff to furnish care that is above and beyond what we currently provide in home care. Tasks related to client well-being in a home health environment would encompass things like: wound care, disease process planning (education), and medication management, to name a few. Currently, our caregivers are not licensed to handle those types of client needs. Seacrest at Home already employs two R.N.s, so this is a logical next step and adds another arrow in our quiver. As far as the Seacrest organization is concerned, this development gives further dimension to our environment of compassion as we can also provide these new services to Seacrest Village residents.

Additionally, the way we are structuring our home health business will feature a slightly different model than other home health agencies. Rather than arranging ourselves as a certified home-health agency, one where we accept payment from Medicare and others, we will operate under a private duty or fee-for-service model. In this model we will be unencumbered by time-consuming requests for reimbursements. Instead, we will accept payment for services as they happen, providing stable cash flow and greater flexibility in these early stages of growth. Past that, this structure gives us the ability to pursue contracting opportunities with big healthcare organizations like Scripps or Sharp to serve some of their ever-growing client population.

Our home-health license was submitted to the appropriate agencies earlier this year, and we anticipate being ready to deliver services as soon as we complete an on-site survey. We have discussed plans on moving to a certified home-health model within a couple of years.

As always, we look ahead to the future, rather than what we've accomplished in the past, and we are eager to bring our unique brand of quality compassion and service to our new venture that we've brought to hundreds of clients over the past seven years.

For me, one of the real pleasures in life is being Jewish and giving back; and having a husband that is loving and generous is another.

Having not endured the horror of being in a camp, I still feel like a survivor. At the end of 1942 my 7 months pregnant mother left Gdansk (Danzig) on a freighter to Sweden. I was born on the lower deck in the middle of the Baltic Sea. We lived in Sweden until 1947 with a lovely Swedish family. My first language was Swedish. My mother had learned that her sister and brother perished in camps and that her husband was never found. However, she did find her childhood friend who helped her escape with the Jewish Underground, now living in Germany.

After many years living in L.A. and retiring, I moved to San Diego where I met my loving husband David Koplar and got married after 20 years of being a widow. We met on "Our Time" a dating site. I was now looking for something meaningful. The wonderful Kelli at "Seacrest At Home" contacted and hired me. I was thrilled and thankful!!! The comfort of taking care of "my people" and anyone in need of care and love gave me the greatest joy. I always felt that I was the one on the receiving end. "Seacrest At Home" is such a special place and treats everyone equally with gentleness, kindness and most of all respect.

It made me proud to be part of this beautiful organization and be a caregiver with love and compassion to wonderful human beings, some sadly gone, some still around. This "love service" has enriched my life and hopefully others.

Resident Spotlight

Edie Greenberg is a chef, teacher, born-and-raised San Diegan, saver of marriages, grandma to six, and now we are honored to have her as a Seacrest Village resident. Over the years, she has touched our Jewish community in many ways.

Edie Greenberg, age 85, was born and raised in the San Diego Jewish Community. She grew up in a Kosher home, and her parents, Pauline and Charles Press, helped establish Beth Jacob Congregation. She married a young,

charming, and handsome Dean Greenberg, whose parents, Lee and Zell Greenberg, helped launch Tifereth Israel and were founders of the original San Diego Hebrew Home on 54th Street. Lee Greenberg was involved with the Jolly 16, the group of women credited with starting the "San Diego Hebrew Home for the Aged" with ten beds in its first home on 4th Avenue in San Diego. Edie and Dean's wedding was attended by a crowd of 700 who loved this special couple.

Edie's father-in-law, Zell, was an extraordinary chef. He owned drive-ins as well as the Rosarito Beach Hotel. Edie wanted to impress her father *and* motherin-law, so she decided that she was going to learn to cook, and cook well! As a young couple,

You may remember her monthly column in the San Diego Jewish Times, "Edie's Edibles", that ran for 25 years with a new, creative recipe showcased each month. Throughout her career, she developed friendships with

> some of the most celebrated chefs of our time: Julia Childs, Jacques Pepin, Martha Stewart, and many more. She appeared on The Food Network, in *Gourmet Magazine*, *The San Diego Union Tribune*, and shared her knowledge and love of cooking with so many in our community.

"I've never met a more beautiful person. We should all take lessons from her," says her close friend since grade school, Lee Goldberg of San Diego. Lee was not merely referring to cooking lessons; she was talking about *life lessons*. To illustrate, here is how Edie reacted when asked how she felt about the food served in her new home of Seacrest Village (coming from a master chef, we were nervous about the answer): "I don't have to shop, chop, cook, clean the dishes... I LOVE IT. It's delicious." Not one negative comment!

Edie and Dean spent time in Paris, where Dean was stationed in the U.S. army. Edie fondly remembers taking cooking classes across the world, including some at Le Cordon Bleu, Paris.

She taught cooking classes all over San Diego in community colleges, at the Salvation Army, recreation centers, anywhere she could find to make her classes free or very affordable so that more people would be able to enjoy and benefit from them. Edie's grateful, positive perspective is infectious. Throughout the ups and downs of life, if we were all to appreciate what we *do* have instead of focusing on what we don't, like Edie Greenberg, we would enjoy infinitely

Two recipes from Edie's collection for Rosh Hashanah: Sweet recipes for a sweet year!

INGREDIENTS:

3 cups flour

1 teaspoon baking soda

½ teaspoon salt

2 cups sugar

1 teaspoon cinnamon

3 cups peeled and chopped Granny Smith apples

1 ½ cups chopped toasted pecans (see note) 1 ¼ cups oil

3 eggs, beaten

2 tablespoons vanilla

Marie Hopper's Raw Apple Cake (Mixmaster not necessary)

DIRECTIONS:

Brown Sugar Glaze (see accompanying recipe)

Pre-heat oven to 350 degrees. In a bowl, mix flour, baking soda, salt, sugar and cinnamon. Stir in apples and pecans.

In another bowl, combine oil, eggs, and vanilla. Stir wet ingredients into dry ingredients until just mixed. Do not use an electric mixer.

Pour batter into a greased and floured 12-cup Bundt pan. Bake in preheated oven for 1 hour, or until a toothpick inserted in center comes out clean. Pour one-third of glaze gently over surface of cake and let cool for 30 minutes. Invert onto a cake platter and, with a pastry brush, paint the remaining glaze on the outside of the cake.

Note: you can use walnuts, but I like the taste of the pecans. Toast them on a cookie sheet in a 350-degree oven until just browned.

INGREDIENTS:

1 x 4–5 pound Brisket (I use a whole brisket because the flat part alone is very dry. Since you chill it overnight, all the fat can be removed the next day and your brisket will be moister and more flavorful.)

2 medium sized onions, sliced

1-½ cups brown sugar is the amount I like but you can use more or less according to your taste.

2 packages dried onion soup mix

2 cups Manischewitz fruit wine of your choice

My Favorite Sweet Brisket

DIRECTIONS:

Pre-heat the oven to 350 degrees. Take a roasting pan large enough to accommodate the meat.

Layer 1: slices of 1 onion, spread on bottom pan; Layer 2: sprinkle 1 package soup mix over onions; Layer 3: sprinkle half of brown sugar over soup mix. Set brisket fat side up on top of first three layers. Layer 4: spread remainder of brown sugar over meat; Layer 5: spread remaining onion slices over sugar; Layer 6: sprinkle 1 package soup mix over onions.

Pour wine over everything. Cover tightly with pan lid or heavy duty foil. Place in oven for 3-1/2 hours. When meat is fork-tender, remove and allow to cool and place in refrigerator overnight. While the meat is cooling, keep uncovered. Brisket can be made several days in advance up to this point.

Next day, open pan and remove brisket to a cutting board. Remove all chilled fat from pan contents. I use an electric knife to easily cut slices against the grain of the meat. Take pan contents and place in blender. If too thick, add a little chicken soup. Place sliced brisket into an ovenproof serving platter with sides. Pour gravy from blender over brisket. Cover and refrigerate. Some people even do this weeks before and freeze. If you do this, defrost overnight in the refrigerator. Otherwise, remove the dish from fridge a few hours before serving to bring meat closer to room temp. Turn oven to 300 degrees and allow 45 minutes to rewarm, covered with foil. When hot and bubbly, uncover and serve.

Brown Sugar Glaze:

- (Makes about 1 ½ cups)
- 1 cup brown sugar
- 1/2 cup butter
- ¼ cup milk

.

½ teaspoon vanilla

Combine all ingredients in a small saucepan. Heat, stirring, until sugar is dissolved and butter is melted

It's Been Called The Silver Tsunami

Q&A with Carl Measer, Chief Operating Officer, Seacrest Village

"Living in Paradise" is how one Seacrest resident described her home at Seacrest Village. Another resident shares, "I have found friendships that are deep and interesting; this is the place for me."



Carl Measer, COO Seacrest Village

Seacrest strives every day to bring enrichment and joy, as well as comfort and safety into the lives of the elderly in our community, regardless of one's ability to pay.

In these times of growing need, there are challenges, and Seacrest is dedicated to being a source of hope and help for families facing these challenges.



It is estimated that by 2050 people over the age of 65 will represent more than 20 percent of the population, up from just 15 percent today. That shift may not sound significant, but it represents about 40 million additional Medicare-age people flooding the U.S. healthcare system. This 'silver tsunami' is driven partially by advances in the medical community helping people live longer, but also by the large number of retiring Baby Boomers, people born between 1949 and 1964.¹

Over the next 15 years, each day over 10,000 Baby Boomers will reach retirement age. Research shows that 54% of older Americans lack sufficient retirement funds, a concerning number since savings can be depleted quickly with the potential of high medical costs. Declining health and social isolation, particularly after the loss of a spouse, are major factors in a senior's decision to make use of home care or to move into a retirement community, and lack of funds can have a significant impact on their quality of life.²

We spent time with Carl Measer, Seacrest Village's Chief Operating Officer, to learn more about how these trends are affecting Seacrest Village and the community at large. While he recognizes future challenges, he finds great hope and has immense gratitude for the continued support and generosity of our community members.



How have you seen the needs of our senior community change over the decades?

Ten years ago, Seacrest provided \$700,000 per year in charitable care to our residents. Charitable care is financial assistance for those who simply

no longer have the means to provide for themselves and have nowhere else to turn. Currently we provide \$2.5 million annually. At this same rate, 10 years from now, we would theoretically require \$6.25 million per year to care for those in need, but because of the 'silver tsunami' this will potentially not be enough. The number of people requiring financial assistance is growing at an unprecedented rate.



In addition to the Baby Boomers becoming a larger segment of the population, tell us about other trends affecting retirement communities.



What we see is that people are living longer. The average age 50 years ago was 70 and today it is 79, but we are seeing people live to be 95,

100, 105 and few of us plan for this. Resources run out. Pensions are not provided as they were back in the 90s. After 2008, we saw people taking out second mortgages, so we see people with more debt. What savings people have can be easily depleted.

We're also seeing a generational age change. The age gap between parents and children is widening. In the past, children could support either their children or their parents during different times in their lives. They now are hard-pressed to be able to help their parents in their later years, as they are still under financial stress supporting their own children going through college or buying first homes. Residents and family members in a financial bind can come to us and apply for scholarship. To be able to help is an honor.



What about Medicare and Medi-Cal, and things like long-term care insurance? Can these help seniors with financial obligations?

Medicare and Medi-Cal will cover your doctor and hospital bills but they will not cover in-home care or accommodation in a retirement community. Independent Living, Assisted Living and Memory Care are paid for privately. Many long-term care residents in Skilled Nursing also pay privately. That can deplete saved funds very quickly. Many people have Long-Term Care Insurance Policies, but the benefits of these policies need to be reviewed carefully. They may only pay for care in a licensed community or in-home medical care, and the daily reimbursement often does not cover the full cost.



Would anyone know if a resident was receiving charitable care?

No. This information is strictly confidential to maintain each person's dignity. We treat everyone as if they are paying privately. Everyone gets THE

BEST treatment, no matter who they are, or what their financial situation is.

There is no better feeling than to tell a scared family who's loved one has run out of funds, "You don't need to worry. Your parents will be taken care of as long as they need us."



What do you think the future looks like for Seacrest Village with many seniors in need, and the number continuing to grow?



Our ability to continue helping residents in financial need depends on the support of our San Diego Jewish Community, who have given

so generously for the past 75 years. I'm hopeful this tremendous kindness will continue for generations to come.

To be able to provide the love and support to carry someone through these fragile years of their lives is an honor and we want to thank those who have made this possible.








The Viterbi Family Children's Wall




